How We Protect Your Personal Data

Personal data, including your name, email, and phone number, is stored via an autogenerated email and calendar event used by our employees to manage pickleball bookings and storage requests. Emails and events are generated/stored using Google Gmail and Google Calendar. All data is only accessible to our employees, and is not shared to any third parties

While we take all reasonable precautions to ensure that user data is secure and that users are protected, there always remains the risk of harm. The Internet as a whole can be insecure at times and therefore we are unable to guarantee the security of user data beyond what is reasonably practical.

Children

We do not knowingly collect or use personal data from children under 13 years of age.
